This insurance is only for an amount in excess of the greater of the minimum liability limit required by Alberta law or such higher limit of liability provided by the vehicle owner's automobile liability insurance policy.
 - Damage to the owner's vehicle is NOT insured by FFCA.
- The owner of the vehicle is expected to inform his/her insurance agent of the intention to use the automobile and to act as a driver for school activities. The majority of insurance companies do not require an endorsement to auto policies or an additional premium charge because this driving is classified as occasional and is not done for compensation
